







NUMBER OF NEW CASES HANDLED BY SIAC IN THE LAST 29 YEARS






TOP TEN FOREIGN USERS IN 2019



TIME AND COST SAVING MECHANISMS UNDER SIAC RULES 2016

	SIAC RULES 2016
Emergency Arbitration	Appointment of EA within 1 day Issuance of Order or Award of Interim Relief within 14 days from appointment of EA
Expedited Procedure	Monetary threshold of SGD 6,000,000; agreement of parties; cases of exceptional urgency Tribunal may decide to hold documents-only proceedings Award is to be made within 6 months
Early Dismissal of Claims and Defences	Potential to provide significant savings of time and costs Mechanism for early dismissal of claims/defences manifestly without legal merit or manifestly outside Tribunal's jurisdiction
Consolidation and Joinder	Allows related disputes to be heard together (consolidation) and related parties to be heard in one forum (joinder) Prevents inconsistent findings
SIAC-SIMC Arb-Med-Arb Protocol	Time and costs savings if matter settles If mediation is successful, parties may request their mediated settlement be made a consent arbitral award with advantages of enforceability under New York Convention
Multiple Contracts	Provides flexibility to file a single or multiple Notices of Arbitrations in multi-contract disputes Single Notice of Arbitration is deemed an application for consolidation Multiple Notices of Arbitration may be submitted with an application for consolidation
Remedy against a Non-Paying Party	Allows a party to seek reimbursement for paying another party's share of the deposits
