15 – 19 October 2022



On-site Meetings and Company Visits

The OAV – German Asia-Pacific Business Association is organising a cross-sector business trip to Bangladesh from 15 – 19 October 2022.

Business in Bangladesh

Since its independence over 50 years ago, Bangladesh has worked its way up to become the second largest economy in South Asia. The textile and garment industry has contributed to the fact that the country, with a population of almost 170 million, will no longer belong to the group of "Least Developed Countries" (LDC) as defined by the United Nations from 2024.

With a population of around 22 million, the metropolitan region around Dhaka is the economic center of the country. According to estimates, 35% of the total value added in terms of GDP is generated here. In addition to the textile, garment and leather industries, growth sectors such as the pharmaceutical sector, food processing and the information and telecommunications technology (ICT) industry are concentrated in the greater Dhaka area.

The government has identified several sectors that are candidates for the targeted broadening of the industrial

base. These include the pharmaceutical industry, with around 300 manufacturers already contributing just under 2% of GDP, and the automotive and supplier industry, in view of rising demand for cars and high import duties. But the financial and service sector is also developing in step with GDP. ICT is one of the growth drivers here. Further, the government takes an active role in attracting investment, which is also reflected in the development of foreign direct investment (FDI) stocks. Decisive for this development are the energy sector with a share of 30% and the textile and clothing industry with an FDI stock of US\$3.8 billion.

The OAV will provide German companies with comprehensive market insights and practical information needed to assess market opportunities and entry options. Participants will have a chance to learn from experts and German companies already active in Bangladesh and will be introduced to key institutions and stakeholders.



The Business Mission fee is 1,900 Euros (OAV members) or 2,700 Euros (nonmembers) excluding flights and hotels. The companies bear the individual travel, accommodation, and catering costs as well as transport costs incurred on site.
