Business Opportunities in Nepal

Nepal! A paradise for hikers, trekkers and mountaineers, yet little is known about the business opportunities for various industries that Nepal has to offer:

With its high mountains, numerous glaciers, and rivers, Nepal has great potential in renewable energies, e.g. climate-friendly water and solar power generation. The mostly untapped hydropower capacity is estimated at an enormous 83 gigawatt and thanks to strong UV radiation in high altitude regions, there are also plenty of opportunities in solar energy.

The Nepalese government has launched a comprehensive reform programme for public healthcare. For foreign companies in the field of medical technology, new opportunities exist in the provision and servicing of laboratory and hospital equipment.

German-Nepalese trade relations broadly leveled off again in 2021. German exports amounted to 37 million USD in 2021. Imports in the same year, valued at 28.3 million USD, are almost at the same level as in 2019 before Covid. According to a recent report by the Asian Development Bank, Nepal's GDP growth in 2021/2022 was 5.8%. Along with the support of accommodative macroeconomic policies, GDP is expected to remain at around 5% in 2023.

During this delegation trip OAV and Nepal Secretariat of Skills and Training (NSST) will provide German companies with comprehensive market insights and practical information needed to assess market opportunities, entry options, and programs of well-trained professionals. Participants will have a chance to learn from experts and German companies already operating in Nepal and will be introduced to key institutions and stakeholders.
