Agricultural products also make up a significant share of the country's exports: Thus, the world-famous Ceylon Tea is cultivated here. In addition to that, Sri Lanka is also one of the largest exporters of cinnamon and coconut products, such as virgin coconut oil.

Moreover, the country ranks as one of the biggest producers of rubber and is the largest exporter of solid rubber tyres worldwide.
